The Official Publication website issues the following types of publications: published unexamined patent applications, published registered patent applications, published registered utility model applications, published registered design applications, published unexamined trademark applications, published registered trademark applications, published decisions on appeal/trial, and publication editions. You can download these publications from the website.

The *Official Publication Downloading Guide* (this guide) describes how to download publications from the Official Publication website.

1 Before use

1.1 What is the Official Publication website?

The Official Publication website allows you to download publications issued by the Japan Patent Office. The following sections describe the types of issued publications, the publication intervals, and the hours of availability of the Official Publication website.

1.1.1 Downloadable publications

You can download the following publications from the Official Publication website:

- · Published unexamined patent applications
- · Published registered patent applications
- · Published registered utility model applications
- · Published registered design applications
- · Published unexamined trademark applications
- · Published registered trademark applications
- · Published decisions on appeal/trial
- · Publication editions

Note that the types of publications issued by the new publication system after the 2022 system renewal are different from the types of publications issued by the previous publication system.

You cannot download the following publications from the Official Publication website:

- Publications issued by the previous publication system (Publications issued by the
 previous publication system cannot be downloaded from the Official Publication website,
 which is the new publication system after the system renewal.)
- Publications that were issued two years ago or earlier by the new publication system after the 2022 system renewal

1.1.2 Issue dates of publications

The issue dates of publications are shown below. In principle, publications other than published decisions on appeal/trial are issued on every business day of the Japan Patent Office*.

* Business days of the Japan Patent Office do not include Saturdays, Sundays, national holidays, and the New Year holiday period.

1.1.3 Hours of availability of the Official Publication website

The Official Publication website is available 24 hours a day, 7 days a week, including on non-business days of government offices. Note, however, that the website might be temporarily unavailable for maintenance or other reasons.

1.2 Checking the certificate

The Official Publication website uses an SSL server certificate to certify the site owner and encrypt communication. If necessary, check the certificate.

In the Certificate window, on the **General** tab, confirm that the fields **Issued to**, **Issued by**, and **Valid from** display the following information:

- Issued to: www.gazette.jpo.go.jp
- Issued by: GlobalSign Extended Validation CA SHA256 G3
- · Valid from: A valid period




Figure 1-1 The Certificate window



Note

SSL server certificates are issued by certificate authorities (impartial third-party organizations) and certify that communication-destination servers actually exist.

An SSL server certificate includes two keys: a public key and a private key. These keys are used to encrypt personal information, credit card information, and other data transmitted between the web browser and the communication-destination server. Encrypted data can be deciphered only by using the secret key of a server on which the SSL server certificate has been installed, thus preventing malicious third parties from eavesdropping.

Components of the top page window are described below.




Figure 1-2 The top page window

2 Downloading publications or other information

2.1 Downloading publications

You can download the latest publications, or you can download publications by specifying the type of publication and the year and month of publication. For details on how to download the latest publications, see 2.1.1 Downloading the latest publications. For details on how to download publications by specifying the type of publication and the year and month of publication by specifying the type of publication and the year and month of publication.

2.1.1 Downloading the latest publications

In the top page window, click the **Download latest publications** button to display the Download latest publications window. In this window, follow the procedure below to download the latest publications.




Figure 2-1 The Download latest publications window



In the **Select** column, select the check boxes corresponding to the publications that you want to download.

If you want to download all of the displayed publications, click the **Select all** button.



Note

- If you click the **Select All** button to select all of the publications and then click button again, the selection is cleared.
- The value (unit: GB) displayed for **Total size of selected publications** is calculated by using 1,024 MB = 1 GB.
- Click the **Download** button.


A message appears, asking whether you want to download the publications.

Click the **OK** button.

At the bottom of the window, a notification bar appears.

In the notification bar, click **Open file**.

The Downloads folder in Windows opens.

2.1.2 Downloading publications by specifying the type of publication and the year and month of publication

In the top page window, click the **Download publications** button to display the Download publications window. In this window, you can specify the type of publication and the year and month of publication, and then download the applicable publications.




Figure 2-2 The Download publications window

- In **Type of publication**, select the type of the publications that you want to download.
- In **Date range**, specify the period in which the publications to be downloaded were issued.
- Click the **Search** button.

The window displays the target publications.



Note

When you click the **Search** button, you might see one of the following messages:

- MSG-0061-W The specified year or month is incorrect
 If this message appears, make sure that the dates specified in Date range are
 specified in the right order. Make sure the correct months and years are set in Data
 range, and then click the Search button.
- MSG-0063-W No documents match the specified conditions
 If this message appears, there is a possibility that no publications matched the conditions set in Type of publication and Date range. Revise the conditions set in Type of publication and Date range, and then click the Search button.
- In the **Select** column, select the check boxes corresponding to the publications that you want to download.

If you want to download all of the displayed publications, click the **Select all** button.



Attention

You cannot click the **Download** button if the total file size of the selected publications is 8 GB or larger. Check the total file size displayed above the **Download** button, and then change your selection so that the total file size is less than 8 GB.



Note

If you click the **Select All** button to select all of the publications and then click button again, the selection is cleared.

Click the **Download** button.

A message appears, asking whether you want to download the publications.


Click the **OK** button.

At the bottom of the window, a notification bar appears.

2.1.3 Unzipping a ZIP file to view publications


To unzip a ZIP file, use the standard Windows function. The procedure for unzipping a ZIP file is described below.



Attention

If you use a tool other than the standard Windows extraction function, you might not be able to unzip the file because the file size is too large.

- In Windows, open the Downloads folder.
- Right-click the downloaded file and select **Extract All**.






Attention


If you double-click the file, the file open but it will not be unzipped. Be sure to select **Extract All** to unzip the ZIP file.


Select **Show extracted files when complete** and then click the **Extract** button.



The following window appears, and processing to unzip the ZIP file starts.



After the ZIP file is successfully unzipped, the extracted folder is displayed.



2.2 Downloading a list of issued documents

In the top page window, click the **Download a list of issued documents** button to display the Download a list of issued documents window. In this window, follow the procedure below to download a list of issued documents.





Figure 2-3 The Download a list of issued documents window

- In the **File name** column, click the link to the list that you want to download.
 - At the bottom of the window, a notification bar appears.
- In the notification bar, click the **Open file** button.
 This opens the CSV file that you downloaded.

3 Reference information

3.1 About the file name

This section describes the naming conventions for ZIP files, and includes the file name format and an example of a file name.

Format

 ${\tt JP}$ <type-of-publication><serial-number-for-the-applicable-year>. ${\tt zip}$

Variables

The following describes the variables used in the description *Format* above.

type-of-publication

The type of publication is indicated by two characters, as shown below.

A_: Published unexamined patent applications

B: Published registered patent applications

U: Published registered utility model applications

D: Published registered design applications

TA: Published unexamined trademark applications

TB: Published registered trademark applications

J: Published decisions on appeal/trial

N: Publication editions

year-of-publication

This is a four-digit number indicating the year when the publication was released.

• serial-number-for-the-applicable-year

This is a three-digit serial number (starting from 001) for the applicable year.

File name example

If you download Volume 004 of published unexamined patent applications for the year 2022, the file name will be as follows:

Example: JPA 2022004.zip
